Your Eco-Committee was elected democratically, this approach will give selected members a confidence boost and empower them to maximise their Eco-Schools' impacts. Keeping your Headteacher updated on the progress of your Eco-Schools' initiatives, is a good strategy to guarantee buy-in and support from your entire school community. It is great to read that your Eco-Committee took responsibility for completing the Eco-Schools' Environmental Review, wholeheartedly embracing the task. Completing the Environmental Review allowed your Eco-Committee to recognise the positive changes your school has already made and appreciate the future impacts they can create.

Your Eco-Committee engaged with a variety of stakeholders including the office manager, site supervisor, kitchen staff, teachers, TAs, and Headteacher when completing their Environmental Review, this is a great way to engage with different members of your school community and gather their support. This year your Eco-Committee thoughtfully selected topics they were passionate about for their Action Plan. This is a strategic approach that will foster greater engagement leading to better outcomes. Your Action Plan contains a diverse range of activities aimed at creating positive behaviours, making an immediate difference to your local environment, and expanding your Eco-Schools' initiatives into your local community. You have participated in the *Great Britain Spring Clean* and have a team of litter busters who go around each lunchtime and keep the grounds clean and litter-free.
